

Winter Reading Challenge YPRL Major Prize Terms and Conditions 2026

1. **Competition dates:** the competition runs from **Monday 8 June 2025** to **Monday 31 August 2026**.
2. **Eligibility:** Entry is open to all residents of Victoria, Australia aged 16 or over who are current YPRL library members. Employees of YPRL and their immediate families are not eligible to enter.
3. **Entry Requirements:** To enter, participants must be aged 16 or over and a YPRL library member. Complete the survey sent to challenge participants (you must provide your email when collecting a log) either mid-way through the challenge or at the conclusion of the challenge.
4. **Entry Fee:** There is no cost to enter the competition.
5. **The rules of the competition and the prize for each winner are as follows:**

To enter, individuals must

- a. Be aged 16 years or over
 - b. Be a YPRL library member
 - c. Complete the Winter Reading Challenge survey demonstrating participation in the challenge before close of business Monday 7 September 2026.
 - d. Survey submission must include their name, library membership number, age, and email address.
6. **Prize Draw:** YPRL staff will randomly draw the prize winner and one second chance prize winner (in case of unclaimed prizes) on **Friday 11 September 2026**. There will be one prize drawn as shown below. The draw is final, and no correspondence will be entered into.
 7. **Prizes:**
 - Grand prize – Lego Tuxedo Cat Set (1X), Brick (digital device blocker) (1X), custom tote bag (1X), and more
 8. **Notification of Winners:** Winners will be notified by email during the week of **14 September 2026**. The name of the winner may be published on the YPRL Facebook page.
 9. **Prize Collection:** Prizes must be claimed via an acknowledgement of receipt email within 28 days of email notification. If a prize is not claimed within this period, YPRL reserves the right to provide prizes to entrants selected in the second chance draw.
 10. **Use of Entries:** By entering the competition, participants agree that their entries may be used by YPRL for the purpose of notifying them of a prize win. Personal information collected will only be used for the purposes stated in these terms and conditions and in accordance with Yarra Plenty Regional Library's Privacy Policy (https://www.yprl.vic.gov.au/media/00wb55ue/yprl_privacy_policy_february_2023_approved.pdf). YPRL will provide entrant details to Public Libraries Victoria for use in their Big Summer Read National and State prize draws. 13. **Substitution of Prizes:** If a prize becomes unavailable due to circumstances beyond YPRL's control, a substitute prize of equal or greater value will be offered. The winner must agree to the substitution in writing.
14. **General Conditions:** The competition must be conducted in a manner that is not offensive and is not contrary to the public interest. YPRL reserves the right to amend these terms and conditions at any time.
